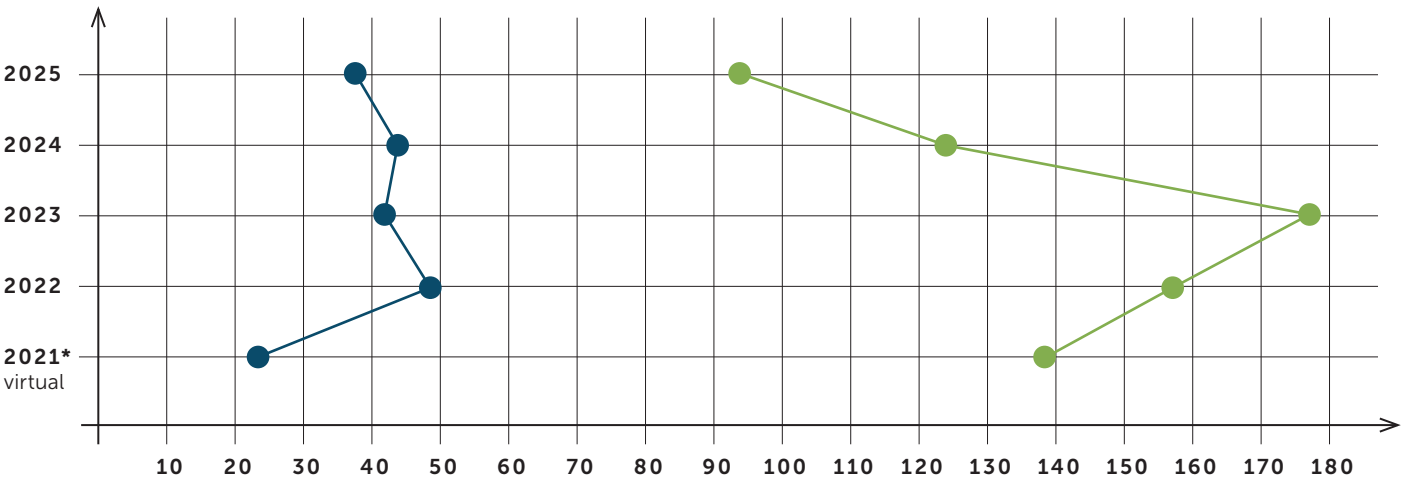

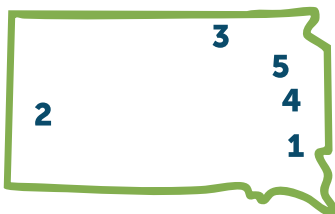

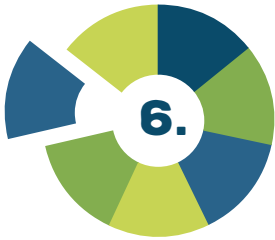


RESPONSE RATE ON STATE CALLS-TO-ACTION

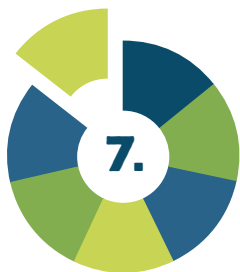

South Dakota Board of Pharmacy

The South Dakota Board of Pharmacy would like to welcome each of you to the 139th SDPHA Annual Meeting. We are sorry our office was unable to attend this year. We have a conflict, and we are currently in Chicago at NABP headquarters reviewing the thousands of MPJE questions that are in the test bank for the South Dakota version of the test.

As you are well aware by now, there was legislation that was passed this year that impacted our office. This legislation gave us a chance to clean up the pharmacy statutes and again a rules package this year that was completed this summer. The new rules go into effect on September 15th. Please see the updates on our website. The work is not quite done, and we are working with the Department of Health and the Legislative Review Council to do a small clean-up on clarification points. Hopefully, this will finalize our cleanup and will help us in our mission to protect the public.

Change can be difficult, but we always try to remind ourselves that change can be a positive thing. We were notified last year that our licensing vendor will be phasing out our current platform. What that means for us is a big change in the office. We are currently in the process of getting bids for the new platform and hope to have the bid process and contract done by October this year, and a timeline on when the new platform will be operational. The goal is to have the

project completed by June of 2026. More news will come on this as we progress. We hope to have little to no disruption for all our licensees during this process.

This year has gone by so quickly, and every day there are new obstacles to address. We have continued to work on DSCSA and continue to try to figure out what that will look like in the years to come for all of the pharmacy industry. We have dealt with questions about IV hydration clinics, USP compliance questions, and the GLP-1 saga that continues to be a challenge for all of healthcare. The latest issue to hit our office is around the COVID-19 vaccines. We are being asked how the lack of ACIP recommendations for COVID-19 vaccines affects whether they can be given in a pharmacy.

As always, it is great to work with everyone in the pharmacy profession; people of South Dakota are so lucky to have all of you. I want to thank all of you for all the work you do for all of us in the state, and I look forward to the future of the profession and what will come. Changes will happen, and it is always exciting to think about what will be next.

South Dakota Society of Health-System Pharmacists

As we enter into the fall season, South Dakota Society of Health-System Pharmacists looks forward to celebrating Pharmacists Month with social events both east and west river in October. We are also excited to reconvene at the ASHP Midyear Clinical Meeting in Las Vegas— for those planning to attend, keep an eye out for details on Dakota Night!

This last year has been productive and filled with several continuing education and networking opportunities. The 49th Annual SDSHP Conference held this past April in Deadwood was a record-breaking success! We welcomed keynote Rick Melmer, a South Dakota native, who spoke on leading self and others through the utilization of DISC. As part of the conference, our participants took the DISC assessment, and were able to apply learnings throughout their homelife and work teams! Many sessions were different during Conference this past year, and we heard great feedback on all! We continue to try to tailor content to students, residents and pharmacists in any area. Board members inducted during the business meeting included Jenna McGeehon as Past President, Aly Howard as President (inducted during an August Board Meeting), Ryan Waybright as President-Elect, Allison Bich-Hofer as Secretary, Morgan Hemmingson as Treasurer, Amy Heiberger and Holly Flynn as Board-Members-At-Large, Jodi Sterrett as Technician Board Member, and Taylor Haring and Faith Richards as Student Board Members. During the awards ceremony, Linda Oyen was recognized as the 2025 recipient of the Gary W. Karel Lecture Award, a massive honor in her mentor's namesake. In addition to the annual conference, SDSHP also hosted resident CE Conferences and Statewide Pharmacotherapy Forum (SPF) sessions throughout the year.

Highlights from the summer months included the residency conference and GVR Open. The 14th Annual SDSHP Residency Conference took place in mid- July. Pharmacy residents from across the state gathered in Oacoma for a day of networking and to learn about topics that will prove beneficial to them during the year ahead. This year, the keynote speaker featured a non-pharmacist presenter who focused on leadership and self-evolution. We heard great feedback, and plan to continue that theme year over year! We owe a thank you to our outgoing resident liaison, Tara Gilk, for her efforts in planning and coordinating the event! The 23rd Annual GVR Open Society Golf Classic was held at the Rocky Run Golf Course in Dell Rapids, SD this July. It was a great day to golf, while also raising money to support pharmacy student scholarships and student travel to the ASHP Clinical Skills Competition in December.

During the upcoming months, SDSHP will continue to work toward goals and objectives outlined in our strategic plan for the 2025-2026 year, including putting formality around strategic planning, an increased social media presence to drive member engagement, and how to continue to educate our members on the legislative process.

SDSU College of Pharmacy & Allied Health Professions

Dan Hansen, PharmD | Dean

The College of Pharmacy and Allied Health Professions at South Dakota State University had a successful year, marked by new grants, renovations at the Sioux Falls Metro Center, and notable faculty and student achievements through awards, research presentations, and publications. The college looks forward to continued success in the coming year.

Big News

We received our NAPLEX results for our 2025 Pharm.D. graduates, which showed a first-time pass rate of 100%. This made SDSU's one of only two Pharmacy schools to achieve a 100% first-time NAPLEX pass rate in 2025.

Similarly, all nine on-campus MLS students that graduated this spring passed the ASCP board exam on their first try, for a 100% first-time pass rate.

Two of our faculty were honored with major SDPHA awards. First, Emily Van Klompenburg was awarded the Distinguished Young Pharmacist Award in recognition for what she has done to promote the profession of pharmacy and her military service. Second, Jodi Heins was awarded the Hustead Award (Pharmacist of the Year), which is the most prestigious award given out by the Association.

The South Dakota Perinatal Quality Collaborative was founded within our Community Practice Innovation Center. With the founding of the SDPQC, South Dakota became the 50th and final state to have its own Perinatal Quality Collaborative. The SDPQC will begin with the BIRTH-SD work, as well as seek additional funding for programs to improve the state of perinatal health in South Dakota. One of our faculty, Stephanie Hanson, is the founder and Executive Director.

The Board of Regents accepted our proposal to add the Pharm.D. program to the list of majors included in SD Advantage, effective Summer 2025. This change now makes it more affordable for a student from any SD Advantage state (Minnesota, Kansas, Missouri, Montana, Wyoming, Colorado, Nebraska, North Dakota, Wisconsin, Illinois, and Iowa) to attend pharmacy school at SDSU.

We participated in SDSU's 10th Annual Pack the Pantry Food Drive, and our college received first place, contributing 2377 of the 2823 food items collected!

Renovation of the Sioux Falls Metro Center began. If things go as planned, renovations will be completed in Summer of 2026. Throughout the renovation, the space will continue to serve our faculty and students at its convenient Sioux Falls location!

For the first time, our Community-Based Pharmacy Residency Program has two residents, following the program's expansion. Catherean Thai and Orion McCartney are our newest residents!

Finally, our Respiratory Care program once again received significant recognition of excellence from the Commission on Accreditation for Respiratory Care (CoARC). Like last year, our respiratory care team received both the "Distinguished RRT Credentialing Success Award" and the "President's Award for Excellence in Credentialing Success Award."

Funding + Grants

Last September, during One Day for STATE, the College received 206 gifts totaling \$127,370, a new record! These funds will make a big impact on all of the programs in our College.

SDSU College of Pharmacy & Allied Health Professions

Dan Hansen, PharmD | Dean

Our START-SD team (whose work focuses prevention, treatment, and recovery of substance use disorder in the state), was awarded a 4-year, \$3 million grant from the Health Resource and Services Administration. The work that will be completed through this grant includes working with three prisons in South Dakota to increase reentry resources and programming for those exiting SD prisons and their loved ones.

Our Medical Laboratory Science program received new, state-of-the-art microscopes and other equipment, thanks to a \$750,000 award from the Centers for Disease Control through the South Dakota Department of Health. The new equipment will make learning more accessible, including facilitating the remote offerings within the MLS program.

Faculty + Staff Highlights

- Faculty from our college have published more than 20 papers in peer-reviewed journals over the past year.
- Josh Reineke was selected to be a member of the 21st cohort of the Academic Leadership Fellows Program through the American Association of Colleges of Pharmacy.
- The Annual State Conference for Respiratory Therapists was held in October. Marissa Trosen was recognized as the Respiratory Therapist of the Year for the State of SD.
- Hemachand Tummala was elected to be the Chair-Elect of the Pharmaceutics SIG in AACP.
- Jeremy Daniel was selected as a fellow in the American Association of Psychiatric Pharmacists (AAPP).
- Chris Robbins was selected for the American Academy of Health Behaviors Research Scholar program.
- Stacy Peters was nominated for a 2025 Sanford Nursing Award in the category of Friend of Nursing.
- Stephanie Hanson and Jim Amell were featured on an episode of "On Call with the Prairie Doc." The focus of the episode was Health Differences vs. Health Disparities.
- Kristy Ullom was elected as the chair-elect of the Administrative and Financial Officers SIG within AACP.

Student Highlights

- The SDSU Pharmacy program felt an international impact. We had five students join us from the Kwame Nkrumah University of Science and Technology in Ghana join us for a few weeks. During their stay, these students participated in different educational and clinical activities during their time here. Additionally, two of our pharmacy students, Sierra Schmidt and Tony Tran, went to Vietnam to participate in a five-week Advanced Pharmacy Practice Experience rotation.
- Karabi Saha, a Ph.D. student, earned 3rd place (out of 30 participants) in the University's Three Minute Thesis (3MT) Competition.
- Fabius (Aime Irabin) (a PhD Candidate) and his PhD advisor Josh Reineke recently had an article titled "Synthesis of immunomodulatory biomimetic lipid polymer hybrid nanoparticles and application of zebrafish larvae in immunomodulation screening" published in the European Journal of Pharmaceutical Sciences.

SDSU College of Pharmacy & Allied Health Professions

Dan Hansen, PharmD | Dean

- Our SCAPP Chapter received honors at the APhA annual meeting. They took home two regional awards and received 1st Runner-Up in the Division AAA Chapter Achievement Award.

SDPhA Articles of Incorporation

We the undersigned for the purpose of forming a South Dakota Corporation under SDCL 47-22 the South Dakota Nonprofit Corporation Act adopt the following Articles of Incorporation for said corporation:

ARTICLE I - Name

The name of this nonprofit corporation shall be: South Dakota Pharmacists Association hereinafter referred to as the "corporation".

ARTICLE II - Duration

This corporation shall continue in existence perpetually unless dissolved pursuant to law.

ARTICLE III - Purposes

The purposes for which this corporation is organized shall be:

- A. To serve as the state professional society of pharmacists which represents the profession of pharmacy enhances the public's awareness of pharmacy and serves the best interest of public health and pharmacy.
- B. To communicate with members, state officials, legislators, and others regarding the need for legislation consistent with goals and objectives of this corporation; and to form similar interest groups to allow autonomy and separation of funds and subsidiaries. To facilitate these purposes the corporation shall have any and all powers of any kind and nature whatsoever as are enumerated in SDCL Chapters 47-22 to 47-28 inclusive known as the South Dakota Nonprofit Corporation Act and all acts amendatory thereto.
- C. To make distributions to organizations that qualify as exempt organizations under Section 501(c) (3) Section 501(c) (4) and Section 501(c) (6) or any state territory or political subdivision exempt under Section 115 all of the United States Internal Revenue Code and laws amendatory thereto or the corresponding provisions of any future United States Internal Revenue law.
- D. Notwithstanding any other provisions of these articles The Corporation shall not carry on any other activities not permitted to be carried on by corporations exempt from federal income tax under Section 501(c) (6) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.
- E. The foregoing purposes and powers are not limitations upon the corporation and the corporation may engage in any legal endeavor allowed by the laws of the State of South Dakota the laws of the United States and the laws of any state in which such corporation operates.

ARTICLE IV - Members

The corporation shall have members both voting and non-voting. Voting members shall be those individuals who have a current annual certificate of registration to practice pharmacy in South Dakota as provided in SDCL Chapter 36-11. The corporation shall have such non-voting members as are provided for under its By-Laws.

ARTICLE V - Distribution & Dissolution

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its directors or officers or other private persons except that the corporation shall be authorized and

empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

Upon the dissolution or final liquidation of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all assets of the corporation for the purposes hereinbefore set forth in Article III or otherwise within the intentment of Section 501(c) of the Internal Revenue Code.

ARTICLE VI - IRS References

All references in these Articles to sections of the United States Internal Revenue Code shall be considered references to the Internal Revenue Code of 1954 as from time to time amended and to the corresponding provisions of any similar law subsequently enacted.

ARTICLE VII - Principal Place of Business

The principal place of business of this corporation shall be at 215 W Sioux, Pierre, South Dakota and any branch or places of business may be established and business conducted at other places in the State of South Dakota or elsewhere as the directors may from time to time provide. The registered agent at such address shall be Tobi Lyon or his or her successor.

ARTICLE VIII - Board of Directors

The affairs of the corporation shall be managed by a Board of Directors. The number of directors of the corporation shall be not less than three (3). Subject to such limitation, the number of directors shall be fixed by the corporate By-Laws. The number of directors constituting the initial Board of Directors is six (6) and the names and addresses of the persons who are to serve as initial directors are:

ARTICLE X - Limitation on Liability of Directors

The private property of the directors, officers, employees, and members of the corporation shall not as such be liable for the obligations of the corporation. A director of the corporation shall not be liable to the corporation or its members for monetary damages for breach of directors duties to the corporation or its members except for breaches of the directors duty of loyalty to the corporation or its members; acts or omissions not in good faith or that involve intentional conduct of a knowing violation of the law; transactions from which a director derived an improper economic benefit; or conflict of interest transactions loans or guarantees for directors and officers or unlawful distributions.

ARTICLE XI - Indemnification of Officers & Directors

The corporation may as appropriate indemnify its officers, directors, employees or agents including former officers, directors, employees or agents to the full extent permitted by law particularly as provided in SDCL 47-22-65.1 through SDCL 47-22-65.8 inclusive and all acts amendatory thereto. The corporation may make any other indemnification which shall be provided for by the By-Laws Agreement vote of corporate members or directors or otherwise and this Article shall not exclude any other right to which such person may be lawfully entitled.

ARTICLE XII - Amendments

These Articles of Incorporation may be amended in the manner authorized by law at the time of amendment.

SDPhA By-Laws Current

ARTICLE I – Name

Section 1. The name of this Corporation is the South Dakota Pharmacists Association.

Section 2. The principal office of the corporation shall be in the City of Pierre, State of South Dakota. The business of the Corporation may be conducted at any place convenient to the Board of Directors and officers.

Section 3. The object of the corporation shall be to fulfill the purposes set for the in the Articles of Incorporation.

ARTICLE II - Membership

Section 1. The Association shall consist of active members, associate members, student members, pharmacists emeritus life members, and honorary members.

Section 2. All registered pharmacists in the State of South Dakota who have secured a current annual certificate of registration to practice pharmacy from the State Board of Pharmacy may be active members of the Association. Active members are entitled to all of the rights and privileges of the Association and may vote serve as an officer or director of the Association and participate in all of the meetings of the Association.

Section 3. Any person not eligible for active membership who is interested in the objectives and advancement of this Association may be admitted to associate membership in the Association under such terms as may be determined by the Board of Directors. Associate members shall be eligible for all services of the Association but may not vote or hold office in the Association. The annual membership fee shall be set by the Board of Directors.

Section 4. Previously registered pharmacists who no longer wish to meet the requirements necessary for licensure as a pharmacist in South Dakota shall be allowed associate membership with the title of Pharmacist Emeritus. Pharmacists Emeritus shall be eligible for all services of the Association but may not vote or hold office. The annual membership fee for a Pharmacist Emeritus shall be one-half the annual fee for licensure as a Registered Pharmacist in South Dakota.

Section 5. Pharmacists who have been registered for fifty years and have been members of the Association for at least twenty years and no longer wish to meet the requirements necessary for licensure as a pharmacist in South Dakota may be granted life membership by the Board of Directors. Life members shall be eligible for all services of the Association except that they shall not be liable for any membership fee nor vote or hold office.

Section 6. A person who may be thought worthy of the distinction may be granted honorary membership by the Board of Directors and shall be eligible for all services of the Association except that they shall not be liable for any membership fee nor vote or hold office.

Section 7. Students who are registered in an accredited College of Pharmacy are eligible for student membership. Student members shall be eligible for all services of the Association but may not vote or hold office. They shall be eligible to be appointed to committees of the Association and are entitled to vote within that committee. The annual membership fee shall be set by the Board of Directors.

ARTICLE III - Meetings

Section 1. The annual meetings shall be held each year at such time and place as the Board of Directors may elect.

Section 2. Special meetings shall be called by the President upon the written request of 25 members or by action of the Board of Directors. The notice shall state the object of that meeting and no other business shall be transacted at that meeting. The Executive Director shall give fifteen days notice of all special meetings.

Section 3. Quorum - Twenty-five active members shall constitute a quorum for the transaction of business but a lesser number may meet and adjourn from time to time until a quorum is present. All active members shall be entitled to vote in person at meetings of the Association.

ARTICLE IV - Board of Directors

Section 1. The Board of Directors shall be comprised of the Association officers, Immediate Past-President, and two At Large board members. The Executive Director shall serve as the Recording Secretary of the Board in an ex-officio capacity with no vote and is not a member of the board of directors.

Section 2. The Board of Directors shall manage the affairs of the Association in the interim between the annual meetings and transact any business that may be necessary. The Board shall render a full report of each meeting to the membership within a reasonable time.

Section 3. It shall be the duty of the Board of Directors to develop legislative policy of the Association.

Section 4. A majority of the voting members of the Board of Directors shall constitute a quorum for meetings. A majority vote of the Board is required for the transaction of business.

Section 5. The Board of Directors is empowered to appoint an Executive Director and other personnel for the Association fixing the duties and salaries of the same.

Section 6. The Board of Directors shall meet with the Board of Pharmacy at least once a year and as often as necessary to conduct business common to both entities.

Section 7. Any action required by law to be taken at a meeting of the Directors or any action which may be taken at a meeting of Directors, may be taken without a meeting if a consent in writing setting forth the action so taken shall be signed by all Directors entitled to vote with respect to the subject matter thereof.

Section 8. The Board of Directors need not conduct a meeting at a geographic location, and may instead hold a meeting by any means of electronic communication which allows the members to read or hear the proceedings, vote on matters submitted to the members, pose questions and make comments.

ARTICLE V - Officers

Section 1. The Officers of this Association shall be a President, President-Elect, Vice President, and Treasurer.

Section 2. The President shall preside at all the meetings of the Association and the Board of Directors. The President shall have the power to call special meetings of the Association when deemed necessary by the Board of Directors or upon the written request of twenty-five active members. The President shall present a report of the operations of the Association at the annual meeting of the Association, be an ex-officio member of all committees, and perform other duties as may be required. The President shall have power to appoint standing and ad hoc committee members.

Section 3. The President-Elect shall preside at any meetings of the Association or Board of Directors when the President is absent and assist the President in performance of duties. In the event of disability or at the request of the President the President-Elect shall perform all the duties of the President.

Section 4. The Vice President shall preside at any meeting of the Association in the absence of the President and the President-Elect.

Section 5. The Treasurer shall keep a full and accurate account of all receipts and disbursements and oversee all monies and other valuable effects in the name and to the credit of the Association in depositories designated by the Board of Directors. Along with the President the Treasurer shall approve all disbursements of the funds of the Association and submit to the Board of Directors whenever they may require it an account of all transactions and of the financial condition of the Association. The Treasurer shall annually make a report of the financial condition of the Association to the members.

ARTICLE VI - Elections and Tenure

Section 1. The active members shall elect a Treasurer and two At Large Members by secret ballot if there is a contest, and if not, by voice vote at the annual meeting for a one-year term. All officers shall be active members of the Association.

Section 2. A majority of all votes cast shall be necessary for election to office. In the event that no candidate receives a majority of votes cast successive ballots shall be cast between the two top candidates until a majority is attained.

Section 3. At the Annual Meeting the President-Elect shall ascend to President, the Vice President shall ascend to President-Elect and the Treasurer shall ascend to Vice President. In the event of a vacancy by reason of death, disability, resignation, or removal, all officers shall ascend one office. The Directors shall appoint a successor to fill the remaining unexpired term.

Section 4. Nominations for office shall be made by districts or individuals to the Executive Director for consideration by the Nominations Committee at least 45 days prior to the annual meeting. Nominees shall be named in sufficient time to allow for publication of their names and a descriptive paragraph prior to the annual meeting.

ARTICLE VII - Removal of Officers

Section 1. All elected officers shall be subject to removal from office for willful neglect of duty acts contrary to the interest of the Association, incompetence or any offense involving moral turpitude committed while in office.

Section 2. Removal proceedings shall be initiated upon the filing of a written petition for removal with the Executive Director. The petition shall contain the name of the person charged, a brief statement of the charges, and shall be signed by at least twenty-five active members.

Section 3. The person named in the petition shall be promptly notified of its filing and provided a copy of the petition.

Section 4. Upon receipt of a petition for removal and notification of the person charged, the President shall call a special meeting of the Association. The meeting should be held in no less than thirty days or more than fifty days from the notification of the person charged.

Section 5. The President shall preside over the removal proceedings, unless named in the petition for removal, in which case the next ranking executive officer shall preside.

Section 6. At the conclusion of the proceedings, the active members shall vote on the petition for removal. A vote of two-thirds of the members present shall be necessary for removal of the person charged.

ARTICLE VIII - Executive Director

Section 1. The Executive Director shall be appointed by the Board of Directors to serve as the Chief Executive of the Association with suitable compensation as determined by the Board of Directors.

Section 2. The Executive Director shall record all proceedings of the Association, conduct all correspondence, be custodian of all books and papers, keep a list of members, their residence, and notify the members of the time and place of meetings.

Section 3. The Executive Director shall collect all monies due the association and make disbursements upon approval of the President and Treasurer.

Section 4. The Executive Director shall serve ex-officio without vote on all committees of the Association including the Board of Directors.

Section 5. Upon termination, resignation, death, or incapacitation of the Executive Director, the President or a designee of the President shall serve as Acting Executive Director until a new Executive Director has been appointed by the Board of Directors, or until that time the Executive Director is able to resume duties.

ARTICLE IX – Committees

Section 1. The President upon assuming the duties of office shall make appointments to fill vacancies of the Nominating Committee and any other active Committee. It shall be the duty of the Nominations Committee to recommend nominees for each office to be elected at the annual meeting. The Immediate Past-President shall serve as the chair of the committee.

Section 2. It shall be within the power of the President and the Board of Directors to create any committees deemed necessary. It shall also be within the power of the members of the Association to create at any regular meeting any ad hoc committees that may be necessary for conducting the affairs of the Association, the duties of each being defined at the time of their inauguration business.

Section 3. - A majority of any committee shall constitute a quorum for the transaction of business.

ARTICLE X – Affiliated Organizations

Section 1. Any South Dakota organization whose membership is interested in advancing the profession of pharmacy may petition in writing to the Board of Directors for status as an Affiliated Organization. Any Affiliated Organization shall be open to any member of the Association who qualifies under the requirements outlined by the Affiliated Organization.

Section 2. An Affiliated Organization shall develop a Constitution and By-Laws or other written organizational structure to govern its activities, which is consistent in principle with the Association By-Laws.

Section 3. An Affiliated Organization may establish a dues structure to support its activities.

Section 4. An Affiliated Organization may conduct projects meetings programs and other activities separate from the Association.

Section 5. Services provided by the Association to any Affiliated Organization and the nature of the relationship shall be established by a written agreement between the Board of Directors and governing officials of the Affiliated Organization.

Section 6. Any Affiliated Organization agreements shall be reviewed every two years by the Board of Directors.

ARTICLE XI – Commercial and Legislative Section

Section 1. The Commercial and Legislative Section shall have the purpose of raising money through voluntary donations, or contributions to carry on the legislative lobbying required to advance the purposes of the Association.

Section 2. The Executive Committee of the Section shall be composed of the Association President, President-Elect, Vice President, Treasurer and the two at-large members.

Section 3. The Executive Committee shall annually set membership classifications and dues. The Executive Committee may accept non-dues contributions to support the Section.

Section 4. Voluntary funds paid into the Section shall be kept separate from Association funds and expended for legislative and commercial purposes under the direction of the Executive Committee.

Section 5. The Executive Committee may hire legislative lobbyists and expend funds for other administrative services as needed by the Section.

ARTICLE XII - District Organizations

Section 1. The Board of Directors may by resolution establish or reorganize a network of District Organizations to serve South Dakota pharmacists.

Section 2. All District Organizations shall hold at least one meeting annually upon the direction of the Board of Directors.

Section 3. All District Organizations shall have a Constitution and By-Laws to govern its activities, which is consistent in principle with the Association By-Laws. The constitution and By-Laws and any amendments made to them shall be approved by the Board of Directors.

ARTICLE XIII - Publication of Proceedings

The proceedings of the Association and other matters of sufficient interest, roll of officers committees and members shall be maintained in the Association Office.

ARTICLE XIV - Parliamentary Rules

The Association shall be governed by the latest edition of the Roberts Rules of Order.

ARTICLE XV - Amendments and Suspension

Section 1. Amendments to these By-Laws shall be made at the Association annual meeting or any special meeting called for that purpose. Proposed Amendments shall be forwarded to the Executive Director at least thirty days prior to the annual meeting or special meeting and shall be sent to active members at least fifteen days prior to the annual meeting or special meeting. All amendments shall be presented to two sessions of the annual meeting or special meeting before balloting. An amendment to the by-laws requires a two-thirds vote of the active members present.

Section 2. These by-laws shall not be suspended without a two-thirds vote.

Code of Ethics

Adopted October 20, 1886

The members of the Dakota Pharmaceutical Association considering it necessary that some mutual understanding should exist in regard to the moral principles guiding them in their profession hereby agree upon the following code of ethics.

We accept the United States Pharmacopoeia as our standard and guide for all official preparations, and recognize a variance from its rules only in exceptional cases, where sufficient authority has proven some other process more reliable to attain the same end. This section is not intended to interfere with the dispensing of prescriptions or medicines ordered in accordance with foreign Pharmacopoeias.

1. Recognizing the value of alcohol as a therapeutic and the propriety of its being dispensed as such by pharmacists, yet deploring the widespread evil resulting from its indiscriminate use in its hundred insidious forms, we condemn any attempt to make it a prominent feature of our business as unprofessional; and we denounce the loose practice of allowing it to be used on the premises, in any shape, as a beverage, as degrading, and we urge upon pharmacists the duty of exercising, at all times, a conscientious care in dispensing a drug liable to such dangerous abuse.
2. We discountenance all secret formulas between physicians and pharmacists, and consider it our duty to communicate such to each other when requested.
3. We distinctly repudiate the practice of allowing physicians a percentage on their prescriptions as derogatory to both professions.
4. We will endeavor, as far as it lies in our power to refrain from compromising the professional reputation of physicians, and we expect the same comity from them.
5. Since the professional training of pharmacists does not include those branches which enable the physician to diagnose and treat disease, we should, in all practical cases decline to give medical advice, and refer the applicant to a regular physician.
6. The growing demands of the age require that those who follow the profession of pharmacy should be educated to a higher standard. Therefore, we consider it our duty individually and collectively, to encourage the advancement of knowledge in our profession generally, and particularly by stimulating our assistants to attend the lectures of a college pharmacy, and by aiding and assisting them to do so.
7. Considering it expedient that some rule should be adopted to enforce the provisions of our code, we hereby agree, if any just cause of complaint of its violation be found against a member of this Association, to bring the case before a special, or at the next general meeting of the Association, when the accused, after being heard in his own defense, may be expelled by a vote of two-thirds of all the members present.
