HB 1005

- This legislation revises certain provisions regarding the use of telehealth technologies.

HB 1014

- This is the **Department of Health's** annual scheduling bill to place certain substances on the controlled substances list, and declare an emergency.

HB 1048

- This legislation revises certain requirements for certain advisory committees under the Board of Medical and Osteopathic Examiners, Board of Nursing, and Board of Social Work Examiners.

HB 1057

- This legislation prohibits certain acts against children and provides a penalty therefor

- **Position: Oppose** – Section 2 (3) of this bill may make pharmacists criminally liable for dispensing certain medications.

HB 1072

- This legislation places certain substances on the controlled substances schedule

HB 1219

- This legislation requires certain health care professionals to recommend treatments alternative to opioids

- This legislation revises provisions regarding immunizations

- **Position: Oppose** – This legislation would prohibit schools from requiring immunizations and make it a Class 1 misdemeanor for any educational institution, medical provider or person to compel another to submit to immunization.
